POWERS AND FUNCTIONS OF THE COMMITTEE

1. The above Committee shall look into the matters pertaining to the Code of Conduct of Teaching Staff, Non-teaching Staff and Students of Santosh Deemed to be University as outlined in the book of Code of Conduct for Teaching Staff, Non-teaching Staff and Students respectively.
2. The Committee may meet at least twice a year [if required, can meet any number of times] to discuss on the various issues, pertaining to the mis-conduct behaviour in the Medical College and the Dental College witnessed during the period.
3. The Committee shall also provide remedial measures for peculiar cases.

4. The Committee also has the power to review / modify / add / delete any of the clauses as mentioned in the book of Code of Conduct. A copy of the book of Code of Conduct for Teaching Staff, Non-Teaching Staff and Students of Santosh Deemed to be University is enclosed in this regard.
5. The Committee shall record the minutes of all the meetings so conducted and send a copy to the Academic Section of the University and to the IQAC for record.

TENURE OF MEMBERSHIP

The Vice-Chancellor, the Registrar, Dean of Medical College and Dental College, Dean Academics and the Director Personal shall be permanent members of the Constitution.

The term of tenure of Membership for the members other than the permanent members of the Constitution shall be 2 Years from the date of enforcement. Such rotatory members shall be eligible for reappointment for one more term on due consideration and recommendations of the permanent members.

This notification shall be enforced with effect from the date of signing.
