The Detailed Terms and Conditions of the project shall be governed by the Contract to be signed between 'Santosh Deemed to be University' and 'Global Infoventures Pvt. Ltd.' as per the draft SIM Contract-ver 1.24 for SMU, already sent by GI on June 4, 2021. The Major Terms and Conditions are summarized below:

Contract Period: 4 years
Minimum Number of Students: 3000
Setup Charges (One time): INR 10 lacs + GST
Cost of Solution:
For New Students: INR 1200 per annum per student + GST
For Existing Students: INR 900 per annum per student + GST

Payment Terms:

- i. For New Students: GI will annually collect the payment, directly from the students through cash collection/ Online payment in July / Start of session.
- ii. For Existing Students: Santosh Deemed to be University will make the payments Quarterly In Advance from July 2021. All the payments shall be made through Cheque/ DD/ NEFT/ RTGS.
- iii. It is noted that as per the Suggestive Matrix, covered in Contract document, Santosh Deemed to be University shall only pay for the active, existing students. As students keep graduating, the payment component of Santosh Deemed to be University will keep on decreasing.

iv. Payment Bifurcation -

- a- 40% of 'one-time setup cost' of 10 lacs + GST with Purchase Order (1st PDC - on the date of signing the contract)
- b- 30% of 'one-time setup cost' of 10 lacs + GST with Purchase Order, (2nd PDC - 10 days after the first PDC)
- c- Remaining 30% of 'one-time setup cost' of 10 lacs + GST with Purchase Order as PDC (3rd PDC - 10 days after the 2nd PDC)
- d- Subscription Cost of 1st quarter as an advance, with Purchase Order, as PDC (4th PDC - 10 days after the 3rd PDC). The actual number of students, excluding final year students, is 2002.

Taxes: GST - 18%

Increment: No Annual Increment during the 4-year contract period specified above. The rate for all the students shall remain frozen for the entire duration of their program.

Lead Time: 30 Days

Others & Miscellaneous:

1. Visit & transportation expenses shall be borne by GI. The Boarding & Lodging expenses shall be borne/ arranged by Santosh Deemed to be University.
2. The lost/damaged Smart-ID card shall be re-issued to the student on payment of INR 200 per card.
3. All the Hardware and Equipment deployed by Global Infoventures during the contract period would at all the times remain the property of Global Infoventures. Santosh Deemed to be University would only have use rights of these during the contract period.

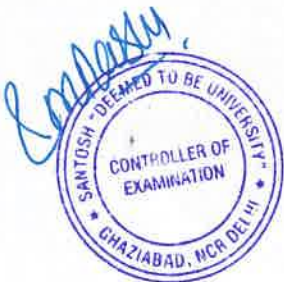
