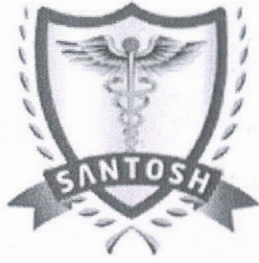



Being a Medical University, our University conducted the examinations in offline mode, as per the NMC/MCI and DCI Guidelines.

## 3. Question Papers Preparation

- Panel of 5 Paper Setters and Panel of 5 External Examiners were obtained from the respective Heads of the Departments.
- Vice-Chancellor selected any two from each panel and 2 sets of question papers for each course were obtained from the respective Paper Setters.

- iii. Around 149 sets of question papers have been received from the external paper setters for various subjects / papers for this year for the conduct of all Regular and Supplementary Examinations at all levels.
- iv. Moderation committee was constituted by the Vice-Chancellor and accordingly question papers were evaluated for validity. Difficulty level of the question papers was also assessed simultaneously.
- v. Three sets of question papers were prepared, printed and sealed for each of the courses for University Examinations.

All panels and Question papers were obtained in a confidential manner from the HODs and respective paper setters. Question Papers were moderated thereafter.

#### **4. Conduct of Examinations:**

- i. The date sheet / schedule of examinations was communicated to the students through mail and through hard copies on the Notice Board of the Institutions.
- ii. Sealed Question Papers prepared for each of the courses for University Examinations were opened 30 minutes prior to the start of each examination by an authorized person nominated by the Vice- Chancellor who chose one set among the three sets, in front of Superintendent of Examinations, Invigilators and students in the examination hall on examination day.
- iii. All Examinations were conducted with Integrity and with high discipline.
- iv. After the examinations, the answer sheets were collected and bundled in the respective covers and sealed properly.

#### **5. Evaluation Process:**

- i. For this Academic Year, overall 95 External Examiners were invited from other institutions from within and outside the state and 91 internal examiners were appointed from the institution for the conduct of Practical Examinations and Valuation of Theory Papers.
- ii. The Answer sheets were evaluated in multiple valuation mode by both Internal as well as External Examiners as per the regulations.
- iii. The results were submitted to the Controller of Examinations on the same day or at the earliest possible along with the answer scripts in a sealed envelope.

#### **6. Results Declaration:**

- i. The results were tabulated, checked and verified.
- ii. The Result Declaration Committee was constituted under the directions by the Vice Chancellor.
- iii. The results were discussed in a meeting of the Result Declaration Committee, after which result were finally passed for release and publication.



iv. Accordingly, the results were published on the Notice Board and at the University Website within a period of 14.3 days on an average.

7. All Examinations are conducted with Integrity and with high discipline.

8. After the examinations, the answer scripts were collected and bundled in the respective covers and properly sealed.
9. The Answer scripts were evaluated by both Internal and External Examiners as per the regulations and the results are sent to the Academic Section in sealed covers.
10. For this Academic Year a total of 136 Internal Examiners were appointed from the Institution and 138 External Examiners were invited for the conduct of Practical Examinations and Valuation of Theory Papers.
11. After the results are tabulated and checked, the Vice-Chancellor constitutes a Result Declaration Board and passes the result to be published and accordingly the results are published in the Notice Board and in the University Website.

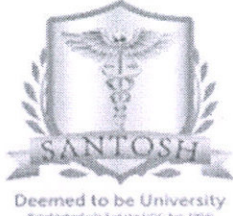


