Introduction

A unique model Institution, Santosh Deemed to be University serves as a distinct institution delivering quality medical/dental education & healthcare services. In addition to offering degrees in Medicine &Dentistry, the University provides an environment for transalational research and innovations in health sciences and comprehensive healthcare.

SANTOSH (Deemed-to-be University) has its roots in a group of Institutions established by the Santosh Trust. The Trust was established in 1995 by one of India's DYNAMIC CARDIOLOGIST, with the mission of empowering youth through quality, affordable health education and health services. The Trust has established 2 institutions spread in two campuses at Ghaziabad UP with allied paramedical Colleges.

Santosh Medical College and Hospital and Santosh Dental Collegeare the two colleges of the Trust, then affiliated to Ch, Charan Singh University and later was declared the two constituent Units of Santosh "Deemed to be University" by Ministry of Human Resource Development on 6th June 2007. Attaining the University status.

Ghaziabad based standalone Santosh Deemed to be University a health University is one of the perfect templates to define quality induced education. For any institution to rise above all and flourish, the quintessential pre-requisite needed is a body of dedicated faculty, sincere administration, and diligent students. When all these three meets and amalgamate, then we get a perfect blend of learning.Santosh University provides today's health sciences students with distinguished and committed faculty, who provide thoughtful and humanistic mentoring. State of the art learning facilities and clinical Labs. in teaching Hospitals. All the colleges are supported by on campus superspecialty teaching and network group of Hospitals. All the courses are recognized by the Ministry of Health and Family Welfare of the Government of India.

The university has been offering an MBBS course since 1995 with a total intake of around 50 students per year. 2005 onwards, the course was recognised by the Ministry of Health and Family Welfare of the Government of India and the capacity of accepting a particular number of admissions was increased to 100. 25 years after its inception, the institute is considered as the best medical university of India.

In the same manner, Santosh Dental College started in 1995 with an aim of imparting a higher level education in dentistry. The institution offers a foundation course in BDS

since 1996 by accepting about 40 students annually. But the number of admissions went up higher to 100 per year after 2005.

The offices of SantoshDeemed to be University are housed on the 4th floor of the Medical College. The University currently offers 58 programs in disciplines related to health sciences and dental Sciences.


These include undergraduate, postgraduate, doctoral and diploma programs. The University has attracted students from almost all the states of India as well as from international destinations. The professional programs have received uninterrupted recognition from the respective statutory Regulatory authorities.

M.Sc and Ph.D Courses were introduced in 2012 which were under the Ambit of Santosh Deemed to be University. . The students are provided with a plethora of 27 value added courses. In addition to their curriculum, 6 teaching programmes are offered at the UG, PG and Ph.D. levels through 29 departments. The students are facilitated to participate in community-connect programmes of village adoption, implementation of all national programmeswhich enable them to evolve as holistic citizens of the country.

We have a standardised 'Mentor-Mentee system' which helps to assess the slowlearners and advanced learners on entry and implement special programmes for both the groups without any stigmatisation. Each mentor would have 10 students under their teacher-parent care system, which will take care of both academic and personal issues. These approaches include bridge and remedial courses, communication skill courses, and psychological counselling services for slow learners. The advanced learners are provided opportunities to take additional courses with extra credits, research projects, conference participation, etc., It is seen that this system has made normalisation of all students and everyone becomes equallycompetent

ADMISSIONS

The admissions to UG / PG Medical and Dental programs for 2020-21 was through merit of NEET only.

The admission to other courses offered by the University is based on merit in the qualifying examination, taking into consideration marks secured in the optional subjects relevant to the course.

EXAMINATION SECTION

Examination section of the Santosh Deemed to be University has been striving continuously since inception to build in a transparent procedure, the conduct of foolproof examinations and announcement of results within shortest possible time frame i.e within 2 days to ten days of completion of examinations depending upon the batch size.

Examinations are conducted in the central examination hall. Presently it has a capacity of 300 to 325 students taking theory examination at one time, in case if the number of students is beyond 300, adjacent lecture hall are utilized for the conduction of the exam.

A unitary seating arrangement is provided i.e. every student has a single table and chair. The examination hall is fitted with CCTV cameras and mobile jammers with the central control room in the Controller of Examination's office list of examinations conducted during the last academic year and the analysis there of is annexed herewith.

Apart from these exams, the Pre Ph.D. course work examinations were also conducted twice ina year, (June and December). The Ph.D. entrance exam was conducted in June and December. In addition to this, Ph.D. thesis submitted by the research scholars is sent for adjudication to three examiners.

The theory examinations were conducted by ensuring precautionary measures such as maintaining social distancing, i.e. the seating arrangement was made in such a way that there was enough gap of a bench (approximately 3 feet) between two students and importantly, theory examination hall, furniture and corridor were sanitized before the commencement of the Examination."

Being a Medical University, our University conducted the examinations in offline mode, as per the NMC/MCI and DCI Guidelines.

3. Question Papers Preparation

- i. Panel of 5 Paper Setters and Panel of 5 External Examiners were obtained from the respective Heads of the Departments.
- ii. Vice-Chancellor selected any two from each panel and 2 sets of question papers for each course were obtained from the respective Paper Setters.
- iii. Around 236 sets of question papers have been received from the external paper setters for various subjects / papers for this year for the conduct of all Regular and Supplementary Examinations at all levels.
- iv. Moderation committee was constituted by the Vice-Chancellor and accordingly question papers were evaluated for validity. Difficulty level of the question papers was also assessed simultaneously.

v. Three sets of question papers were prepared, printed and sealed for each of the courses for University Examinations.

All panels and Question papers were obtained in a confidential manner from the HODs and respective paper setters. Question Papers were moderated thereafter.

4. Conduct of Examinations:

- i. The date sheet / schedule of examinations was communicated to the students through mail and through hard copies on the Notice Board of the Institutions.
- ii. Sealed Question Papers prepared for each of the courses for University Examinations were opened 30 minutes prior to the start of each examination by an authorized person nominated by the Vice- Chancellor who chose one set among the three sets, in front of Superintendent of Examinations, Invigilators and students in the examination hall on examination day.

- i. For this Academic Year, 98 internal examiners were appointed from the institution and overall 98 External Examiners were invited from other institutions from within and outside the state for the conduct of Practical Examinations and Valuation of Theory Papers.
- ii. The Answer sheets were evaluated in multiple valuation mode by both Internal as well as External Examiners as per the regulations.
- iii. The results were submitted to the Controller of Examinations on the same day or at the earliest possible along with the answer scripts in a sealed envelope.

6. Results Declaration:

- ii. The Result Declaration Committee was constituted under the directions of the Vice Chancellor.
- iii. The results were discussed in a meeting of the Result Declaration Committee, after which result were finally passed for release and publication.



DEPARTMENT OF INFORMATION TECHNOLOGY

A Campus Optical Fiber (OFC) Digital Data Network is a computer network that interconnects Local Area Networks (LAN) throughout a limited geographical area, such as a University campus or corporate campus. The networking equipments (switches, routers) and transmission media (optical fiber, copper plant, Cat5 cabling, etc.) are almost entirely owned by the campus tenant/owner: an enterprise, university, government, etc.



Campus Network Topology

College or university campus area networks often interconnect various buildings, including administrative buildings, academic buildings, university libraries, campus or student centers, residence halls, gymnasiums, and other outlying structures, like conference centers, technology centers, etc. training institutes.

All of the nodes in a campus network are interconnected by means of optical fiber media, taking advantage of Gigabit Ethernet or 1-Gigabit Ethernet technology. In some cases, Wi-Fi hot spots or even a hot zone make up the user end of the network, for example, in University student centers or libraries where numerous people simultaneously use portable and mobile devices such as notebook and tablet computers to conduct research and carry on communications.

Computers connected to a network are broadly categorized as servers or workstations. Servers are generally not used by humans directly but rather run continuously to provide "services" to the other computers (and their human users) on the network. Services provided can include printing and faxing, software hosting, file storage and sharing, messaging, data storage and retrieval, complete access control (security) for the network's resources, and many others.

Workstations are called such because they typically do have a human user who interacts with the network through them. Workstations were traditionally considered a desktop, consisting of a computer, keyboard, display, and mouse, or a laptop, with an integrated keyboard, display, and touchpad. With the advent of the tablet computer, and the touch screen devices such as iPad and iPhone, our workstation definition is quickly evolving to include those devices because of their ability to interact with the network and utilize network services.

On a single LAN, computers and servers may be connected by cables or wirelessly. Wireless access to a wired network is made possible by wireless access points (WAPs). These WAP devices provide a bridge between computers and networks.

Students undertake field visits / research projects / Industry Internship / visits/Community postings as part of curriculum enrichment

Oral Health Care to the underprivileged and weaker section of the society is the ultimate goal of Santosh Deemed to be University and Santosh Dental College with its entire work force. To achieve this , undergraduate and postgraduate students from different Dental Departments conducted various Oral Health screening and treatment camps, patient education and motivation on oral hygiene. The Oral Health Awareness programs were conducted on regular interval in various schools and community.

Inspite of COVID pandemic, Santosh Dental College motivated its faculty and students to continuously reach out to the society for promoting good oral hygiene practices. Department of Community Dentistry along with Department of Pedodontics and Preventive Dentistry undertook community-based/school-based research projects either in the field practice areas or schools in the district of Ghaziabad. The unique school health program included oral prophylaxis and preventive treatment creating oral health awareness in both rural and urban communities.

The knowledge of population is necessary to develop and restructure the educational program for children at the school level. Therefore, the tailored educational Oral Health awareness camps increase the knowledge of parents. This would be an adjunct in shaping the values and behaviour in children.

Various activities were organised in the community from time to time on important dental health related issues as well as to observe important National Health Days. Dental undergraduate and postgraduate students along with faculties participated in these activities every year as a part of their field visits. To name a few such activities-Swachch Bharat Abhiyan, World Health Day, World No Tobacco Day, World Oral Health Day etc. Some of these activities were interdepartmental as well as inter-college, involving faculty and students from different departments and the different institutes in the University.




Awareness on Biotech Ignition Grant (BIG) and Startup Ecosystem & Quot – 28.08.2020

Vishakha Guidelines for Sexual Harassment at Workplace

Topic- Vishakha Guidelines.

She explained the contents of The Vishakha Judgement – 1997 wherein, the Supreme Court acknowledged that:

• Sexual harassment is a human rights violation.

• Sexual harassment is a violation of the constitutionally guaranteed fundamental rights:

Articles 14 and 15: Right to equality

Article 21: Right to life - to live with dignity

Article 19(1)(g) - Right to practice any profession/trade/occupation/business, i.e., a right to a safe environment free from harassment.

It is the Employer's duty to prevent and prohibit acts of sexual harassment and also redress and resolve grievances pertaining to sexual harassment.

Object of the Act is Prevention + Protection + Redressal.

The Act defines who is an employer, an employee and also what constitutes a workplace and an extended workplace. It defines what constitutes Sexual harassment under the new law and what circumstances are considered so.

It also explains who constitutes an Internal and Local Complaints Committee in case a complaint is lodged and what the Grievance Redressal Mechanism is for a victim. The act determines the interim reliefs as well as compensations to be granted to the victim along with penalties to be imposed on the accused and employers obligations during the entire process. She also critically analysed the act and explained its strengths and shortcomings as well.



The dry run was aimed at testing the laid out mechanisms for COVID-19 vaccination roll-out in the health system and to assess operational feasibility of using Co-WIN application in a field environment for planning, implementation, & reporting at the block, district, & state level.

The aims also include to identify and rectify fault if any before the actual vaccination. There will be three rooms at each vaccination centre. The beneficiaries will be verified in the first room. In the second room there will be a practice of vaccinating the coronavirus.

In the third room, there will be arrangements to make the beneficiaries sit in observation for half an hour. The govt has said that high-risk groups would be vaccinated on priority. This would include healthcare & frontline workers.

People over 50 years of age & people with comorbidities will also be part of priority groups. Prof.(Dr.)Malay Bajpai & Prof. (Dr.) Prem K.Garg along with PG students Dr.Alok,Dr.Ashi & Dr. Tehseen,Dept of Pathology visited & voluntarily participated in this dry run at Santosh Medical College & understand the preparations for the successful implementation for COVID 19 vaccination in India, which will be the biggest vaccination programme throughout the world, starting from 16.01.2021.


Cancer Screening Awareness Day - 05.03.2021
